Subject: - PIAs practicing manipulation in candidate primary details - reg.

Madam/Sir,

With reference to the letter no. No.- J-17060/33/2020DDU-GKY (373038) dated 7th Nov 2023, regarding introducing new features on Kaushal Bharat effected from 1st January 2024, batch and candidate level mapping is made live on Aadhar Enabled Biometrics Attendance System (AEBAS) portal wherein candidate details registered on Kaushal Bharat is being validated from Aadhaar for the purpose on bio-metric attendance.

It is observed that several PIAs of multiple States/UTs are practicing manipulation of primary details of candidates (**Name**, **Date of Birth and Gender**) while registering the candidates on Kaushal Panjee and subsequently onboarding the Kaushal Panjee ID (KPID) on Kaushal Bharat without proper verification of candidate primary details with respect to the Identity Proof uploaded by the PIA.

In case of any difference in primary details of the candidates may leads to non-authentication of the candidate while onboarding on AEBAS of Rural Skills and this may also result in rejection of assessment & certification of such candidates by the concerned Sector Skill Councils (SSC) in later stages.

Kaushal Bharat is mandated to use KPID as an entry point of the candidates in DDU-GKY ecosystem. Hence, there is no provision of change / update the primary details of a candidate on Kaushal Bharat. In case any change / update is required SRLM/SSDM may update the primary details of candidate on Kaushal Panjee only, so that at given point of time candidate details remain unaltered on both the portal.

In view of the above, it is requested to convey the following instructions with all the PIAs:

- a. Avoid practicing the manipulation of primary details of a candidate and may use the primary details as per Aadhar only.
- b. Verify the candidate primary details available against KPID and Aadhar while registering the candidate on Kaushal Bharat. In case of any difference observed may request SRLM for necessary corrections prior to registration on Kaushal Bharat.
- c. No change request in candidate's primary details on Kaushal Panjee / Bharat shall be entertained after batch freeze date by the concerned SRLM / MoRD / Kaushal Bharat team.

This is for strict compliance and issues with the approval of competent authority.
